SUBJECT: Medicaid Annual Eligibility Review Training

The purpose of this memo is to inform Case Managers and Residential Providers that training will be provided in March regarding Medicaid resuming annual eligibility reviews. During the Public Health Emergency (PHE), Medicaid did not require annual reviews for continued eligibility. The PHE is scheduled to end May 11, 2023. As a result, the SC Department of Health and Human Services, the state Medicaid agency, will resume annual reviews for Medicaid eligibility April 1, 2023.

It is very important that individuals maintain Medicaid eligibility, as loss of eligibility can impact service access. This training is intended provide case managers and residential providers the information needed to be proactive in the Medicaid Eligibility annual review process, and to ensure the continued Medicaid eligibility of individuals served. Each Case Manager and Residential Provider agency must have at least one representative participate in this training.

The training will be provided virtually on March 14, 2023. Please see link and times below. Though there are two separate trainings scheduled, the material covered in both sessions will be very similar. Each training session will be recorded.
