



## DDSN Executive Memo

**RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers and Previous Rehabilitation Supports Providers Electing to Convert to Waiver Funded Day Program Services**

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects March utilization data. There was 20.8% decrease in the number of individuals served. Each provider served fewer individuals this month. When compared to February's data, there was a small (1.3%) increase in the number of units billed across all providers.

As noted in the memo dated June 23, 2020, and in previous communications, former RS providers are expected to develop plans for self-sufficiency over time, and to implement those plans as DDSN's funding of these programs fades. Given the complications of service provision and expansion in a post COVID-19 environment, DDSN has continued to fund providers at a rate of \$28,000 per quarter over the course of this fiscal year.

DDSN continues to recognize that the timing of COVID-19 has significantly impaired the ability of former RS providers to move forward with previous plans for achieving self-sufficiency through expansion. As a result, DDSN plans to continue funding all former RS providers at the same rate of \$28,000 per quarter through the end of fiscal year 2021. Further, DDSN plans to continue funding the four HASCI Drop-in Centers at the same rate for the first two quarters of fiscal year 2022 (through December 31, 2021). Funding continuation will be re-evaluated at the beginning of the second quarter of fiscal 2022 with appropriate notice submitted to providers prior to the end of that quarter.

In the interim, providers are expected to reassess previously developed plans for achieving self-sufficiency and revise based on current circumstances. DDSN will continue to pull usage data and provide monthly reports to evaluate effort and progress.
