**RE: Continued DDSN Grant Funding of HASCI Community Opportunity Centers**

The purpose of this memo is to provide an update on the progress of former rehabilitation supports (RS) providers which have converted to the provision of waiver funded day program services.

The attached monthly report reflects October utilization data. After an increase in units billed for the previous two months, the number of units billed fell 4.9%, while the number of individuals served remained the same.

As noted in the October memo and report, DDSN has determined to continue funding the centers at the current level through the end of Fiscal Year 2022 with re-evaluation to occur at the beginning of the fourth quarter. Providers must continue to work toward expansion of service provision in order to achieve self-sufficiency.
