Quarter 1 ends Sept. 30, 2023  
Quarter 2 ends December 31, 2023  
Quarter 3 ends March 31, 2024  
Quarter 4 ends June 30, 2024 (DDSN must submit these reports to EBO by 6/30/2024 per proviso).

I do not necessarily expect any expenditures to be reported for the first quarter due to the timing or the funds being released. The more pressing item is the completion of the Disbursement form. Once this information is received, I will be able to process the release of the funds.

I look forward to working with you and Camp Cole this year. Proviso 118.19 contains an appropriation of \$250,000 to be distributed to Camp Cole. These funds have been released by the Executive Budget Office.

The requirements for processing these appropriations have changed several times during the last several years. I am attaching the forms required by the Executive Budget Office. I have also attached the link to the Executive Budget's Office where these forms are located. Proviso 117.21 also requires that you submit quarterly reports to the Agency and identify any subrecipient non-profit entities.
